SPEAKER: Jonathan Muraskas, MD is a neonatologist at Loyola University Medical Center. He has published 250+ peer-reviewed manuscripts and scientific abstracts, has given over 300 national and international presentations, and is acknowledged in the *Guinness Book of World Records* 3 times for the 2 smallest newborns and smallest twins to survive. He has received over 30 teaching awards and was voted Top Doctor in Neonatal-Perinatal Medicine Chicago by his peers 23 times. Dr. Muraskas is an elected member of the AAP National Committee on Medical Liability and Risk Management. Over the last 30 years, he has reviewed 500+ cases as a medical-legal expert and has presented hundreds of times on legal issues involving neonatal care, both nationally and globally.



ABOUT THIS PROGRAM: Legal issues surrounding newborns involve a mix of medical malpractice, ethical considerations, patient privacy laws (HIPAA), and civil rights related to health equity. Dr. Muraskas will examine each of these topics as they relate to newborn care in Labor & Delivery, Mother-Baby, and SCN/NICU departments.

PROGRAM OUTCOME: Participants will be able to adopt protective strategies to reduce the likelihood of errors and litigation, identify and navigate complex ethical dilemmas, know their responsibilities under laws like the HIPPA Privacy Rule, and ensure that all perinatal and neonatal patients, regardless of socioeconomic background or disability, receive fair and equitable access to care and resources.
